What is the UDS Mapper?

- An online mapping tool developed by the AAFP's Robert Graham Center, as part of the *Health*Landscape mapping platform
- Provides access to maps, data, and analyses developed for the Bureau of Primary Health Care by John Snow, Inc. (JSI) using UDS and other relevant data to visualize service area information for Health Center Program (HCP) grantees and look-alikes
- Compares HCP grantee and look-alike data to community/population data and shows spatial relationships between the program, community attributes and other resources



Background: History of the UDS Mapper

- Developed in 2010 by the AAFP's Robert Graham Center, as part of the *Health*Landscape online mapping platform
 - Funded by the Health Resources and Services Administration (HRSA)
 - Based on formulas and reporting methods developed by John Snow, Inc. (JSI)
- Originally created to assist federal project officers to analyze health center service area overlap
- Audience and functionality expanded to allow health centers and grant-seeking entities to understand the safety-net environment in their service area



Background: How can the UDS Mapper be used?

- The UDS Mapper has become an essential tool for:
 - planning
 - grantwriting
 - service area definition and analysis
 - community health needs assessments
- Since launching in 2010, the UDS Mapper user base has grown to more than 8,000 registered users
 - 50% from health centers
 - The other half includes users from:
 - Primary Care Associations and Primary Care Offices
 - HRSA and other federal agencies
 - State or local government
 - Rural Health Clinics, hospitals, others



Who Can Use the UDS Mapper?

- The UDS Mapper is open to everyone, not just Health Center Program grantees and look-alikes
- To begin using the UDS Mapper all you have to do is register for a username and password at <u>www.udsmapper.org</u>
- More than one person from an organization CAN have a login for the UDS Mapper



Going Mobile

- Move to tablets and other portable electronic devices
- Not all functionality makes sense in a mobile translation
- Basic need: A way to make a case when out and about
 - Asking for funding
 - Talking to community leaders/elected officials
 - Congressional reps
- This is who we are, and these are our patients

Geography of the UDS Mapper

- Health Centers report patients by ZIP Code
 - ZIP Codes are an unreliable geography
- Data in the UDS Mapper are mapped by ZCTA (2010)
- What is a ZCTA?
 - ZIP Code Tabulation Area- an approximation of ZIP Codes from the US Census Bureau

 HCP Grantees and Look-Alikes HCP Grantee and Look-Alike Service Access Points Rural Health Clinics National Health Service Corps (NHSC) Sites Facility and Point HPSAs (CHCs, HCP-LAs, RHCs, and tribal organization facilities) 	Explore Service Area Tool
 Hospitals Medically Underserved Areas/ Populations Health Professional Shortage Areas (Primary Care) 	 Basemaps and Optional Layers






Data Considerations

- ZCTAs
 - Changing/evolving ZIP Code boundaries
- Patient Data
 - From the Uniform Data System
 - Health Center Program grantees and look-alikes only
 - ZCTA only
 - If there are 10 or fewer patients from a health center in a ZCTA, those data are suppressed
 - Low-income calculations are based on 100% of patients
 - Calendar year only
 - Organization-level data only








Layout of the Mobile UDS Mapper








Patient Origin Service Area










Tools in the Mobile UDS Mapper








