# Background

- **What is Enterprise Data Integration?**

- Linking organization's data with its core functions
- One core function in every organization is communications.
- One critical activity in communications is keeping communication channels to one important organization's component:

## Its Customers

- **What is Asynchronous Transfer?**

- Sending or receiving data from server resources without rendering the web page

- **Why do we use asynchronous data transfer?**

- To enable communications between JavaScript code and ASP.NET script files

# The Problem

- Receives application for zone change of a property
- Notify owners of properties 500 feet around questioned property and invite them to public hearing
- Keep record of notifications in case a citizen complains of not receiving letter

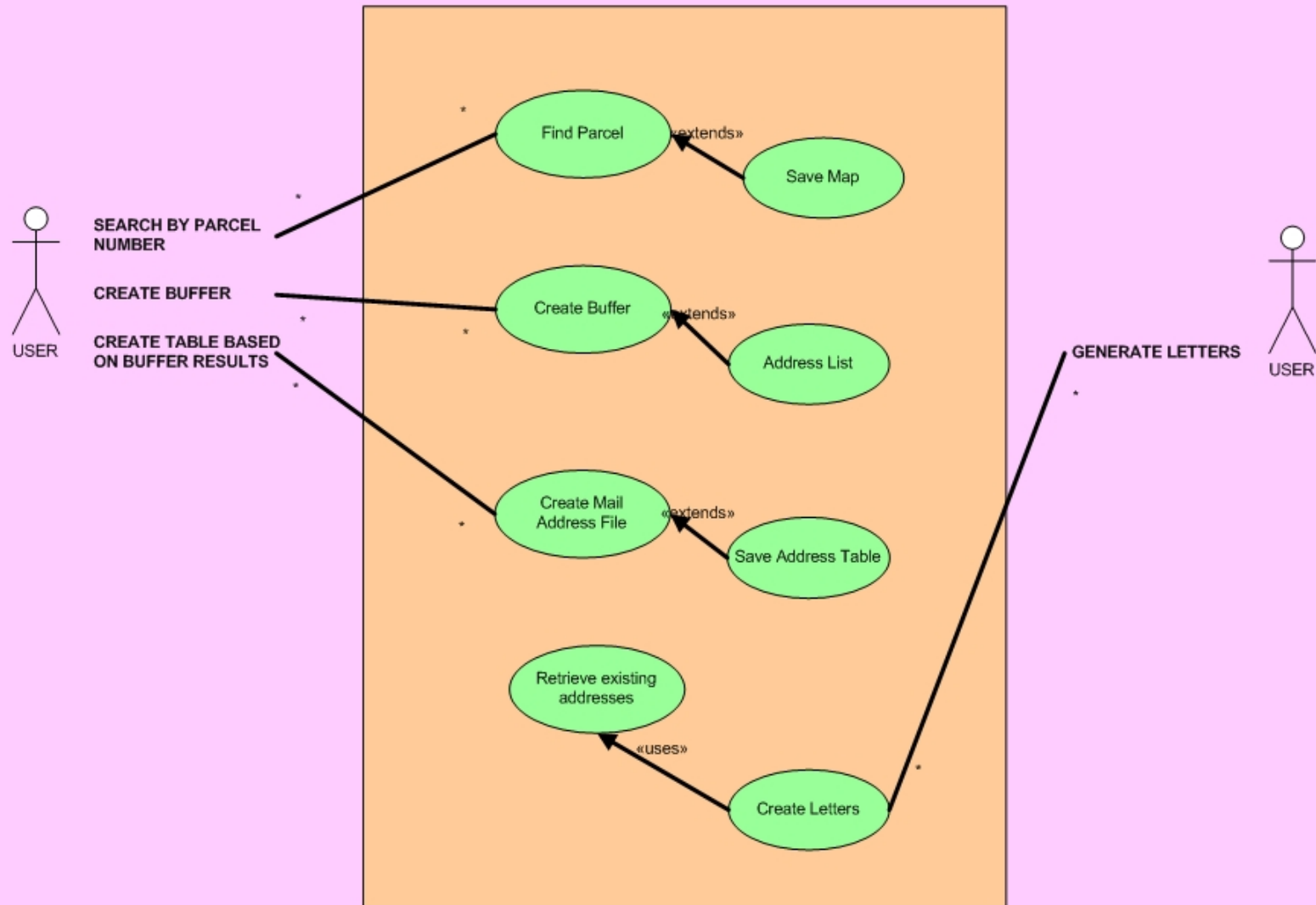
# Existing Conditions

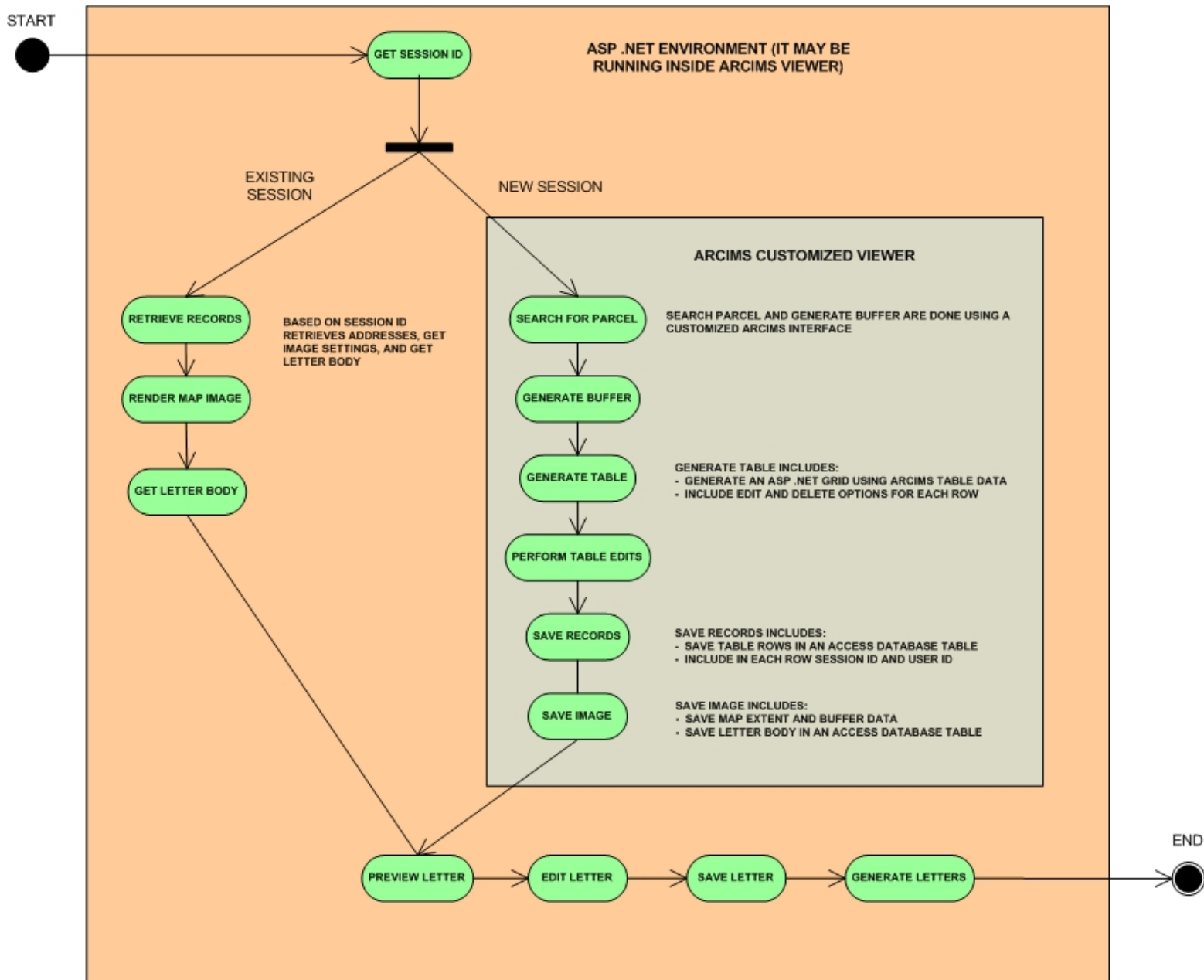
- Parcel search
- Property owners list
- Data Edit: Delete redundant data or correct wrong data (save Excel file).
- Use Crystal Reports to generate letters (save Crystal Reports file).
- Trace map or print one showing area of interest.

# Proposed Solution

- Program to perform property search in a buffer area around property
- Same program inserts letter body
- Saves property owners list in database
- Renders map showing buffer and properties
- Uses saved data to generate letters (mail merge)
- Recoverability: saves data and settings

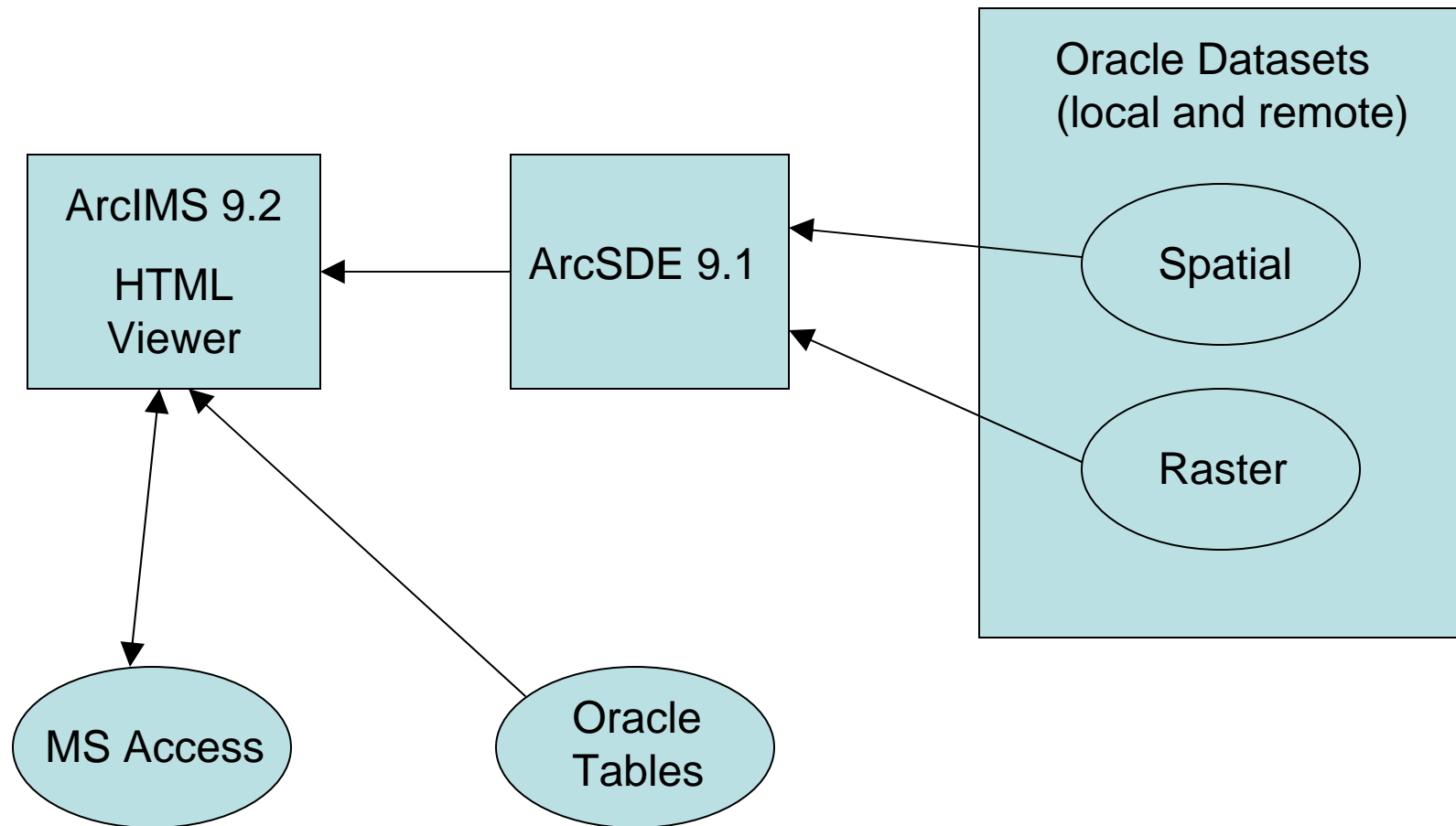


# Solution: Implementation

- Customized ArcIMS 9.2 HTML viewer:
  - JavaScript
  - ASP.NET
  - AJAX
- Spatial data through ArcSDE 9.1
  - Local: BoCC
  - Remote: PAO through fiber optic line
- Read Oracle database tables

# XMLHttpRequestObject

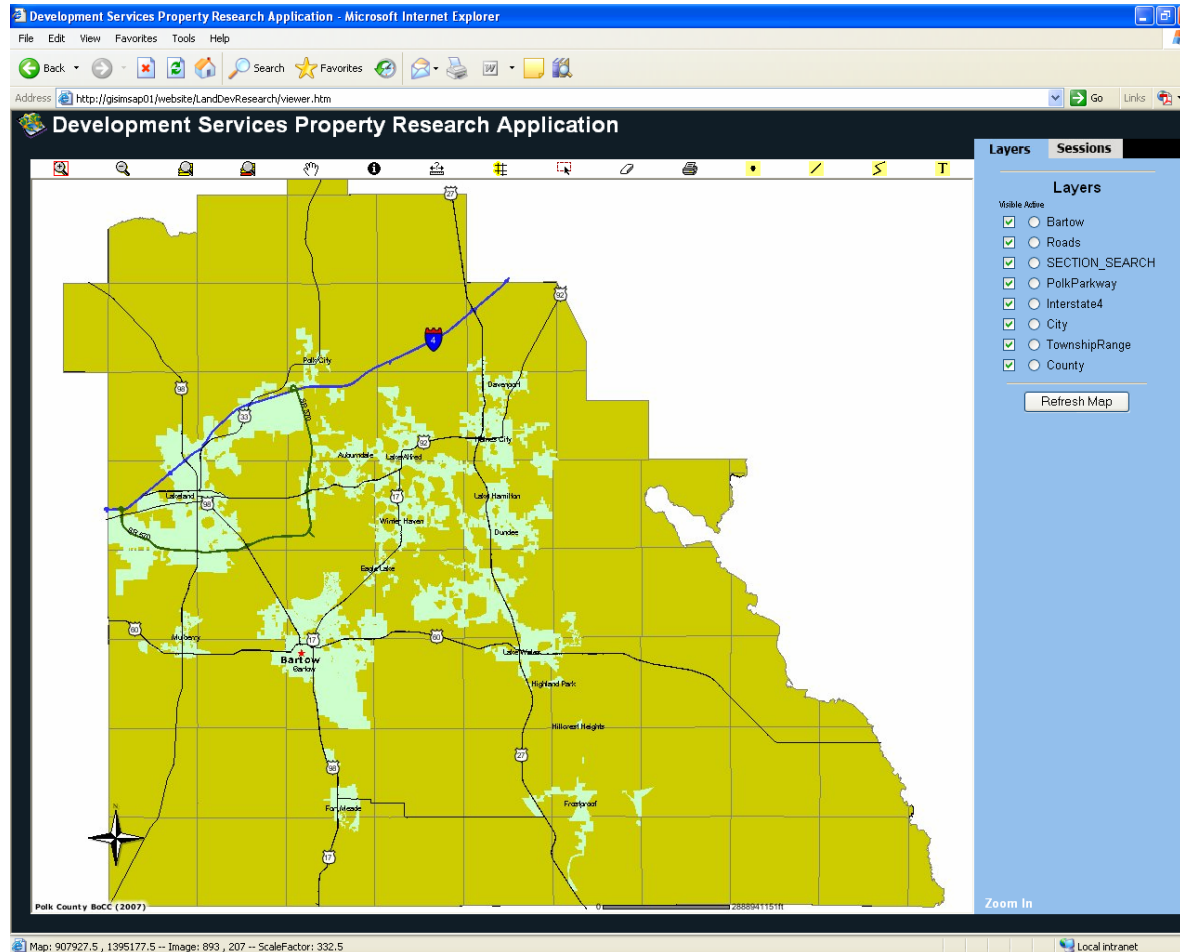
- Code is available in ESRI ArcScripts website: do search using “AJAX” keyword.
- XMLHttpRequestObject is used to send or get data from JavaScript to server side script file (ASP.NET).
- Gets attributes in displayAttributeData Function and stores them in global variable.
- Code in that function calls ASP.NET page that sends data to server using post method.
- Or code calls server side script from JavaScript file as shown in example.

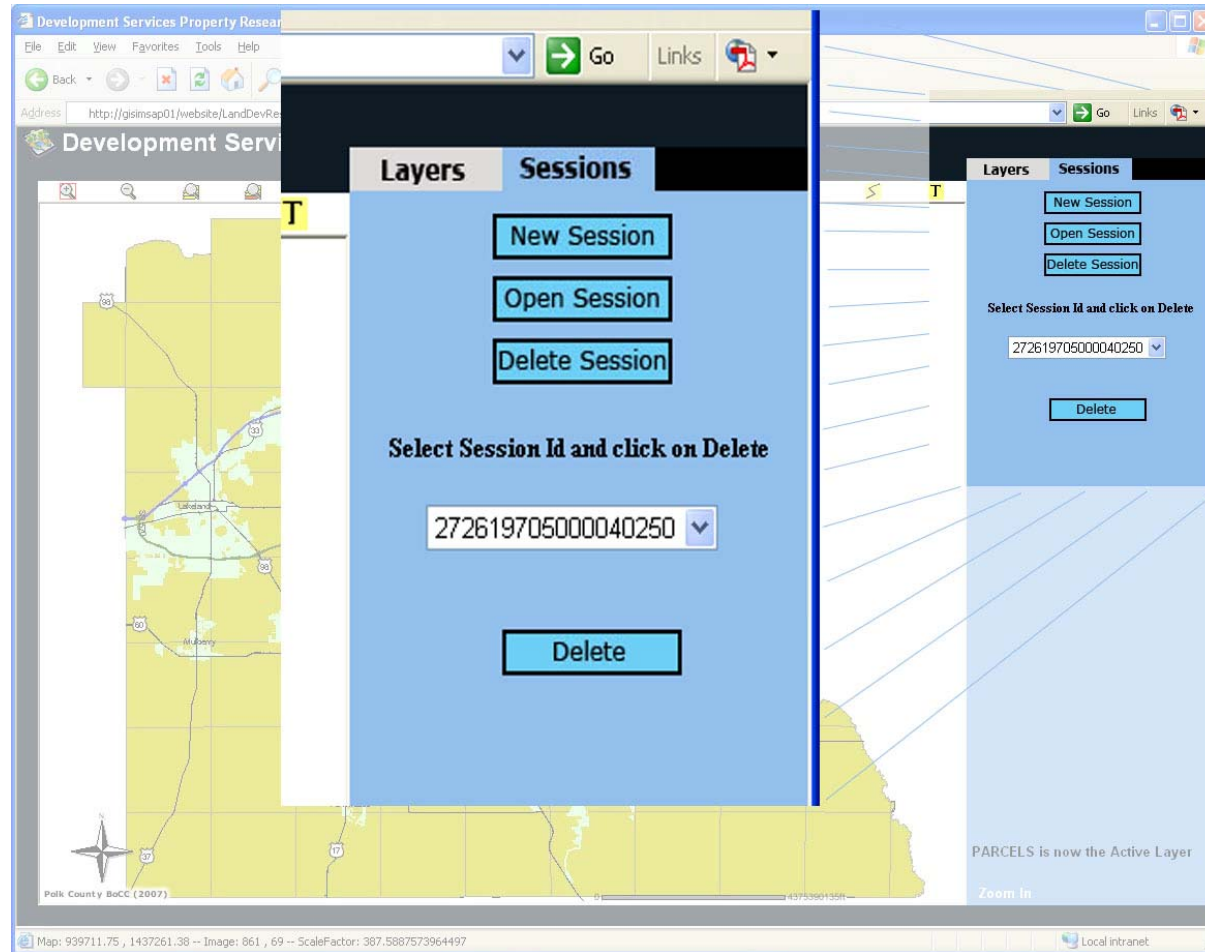

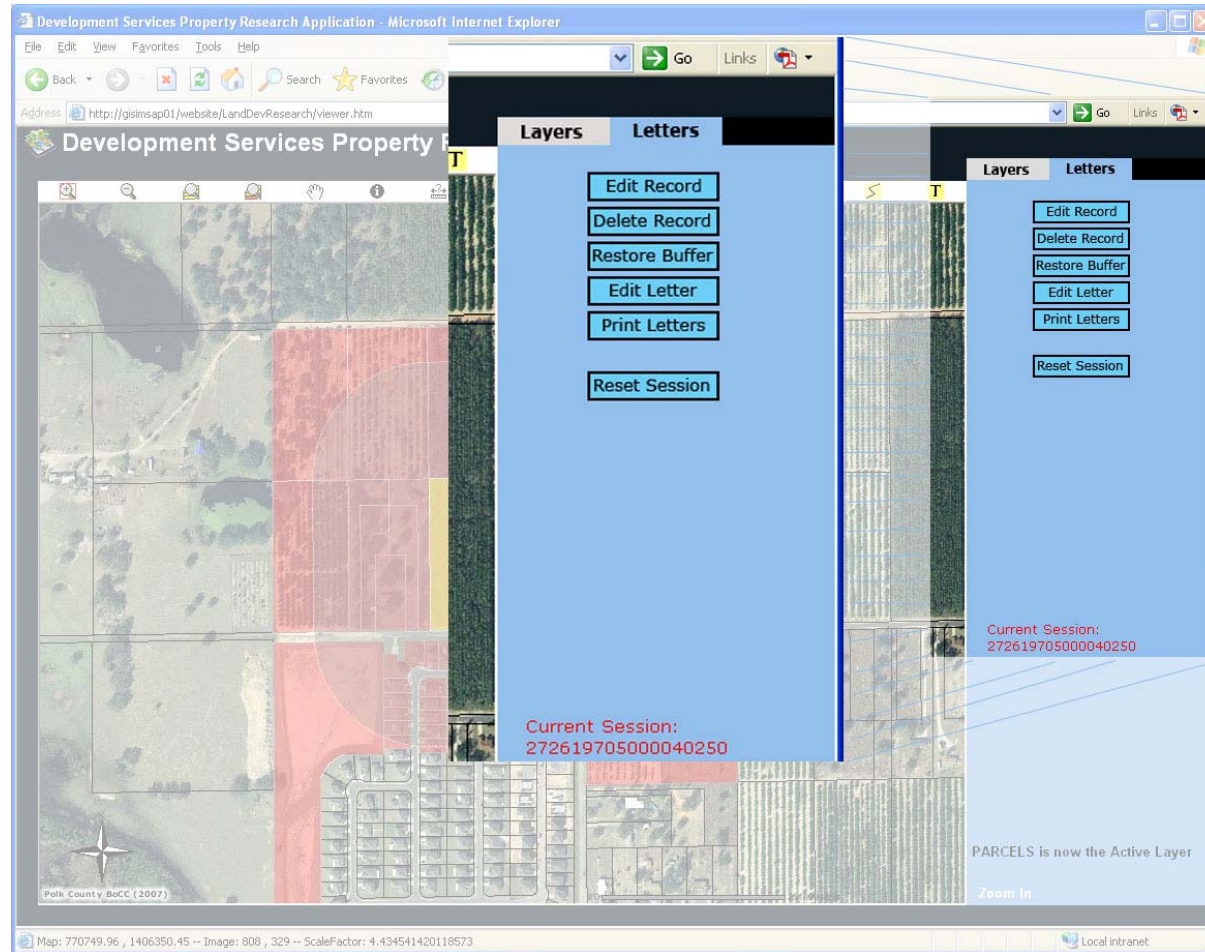

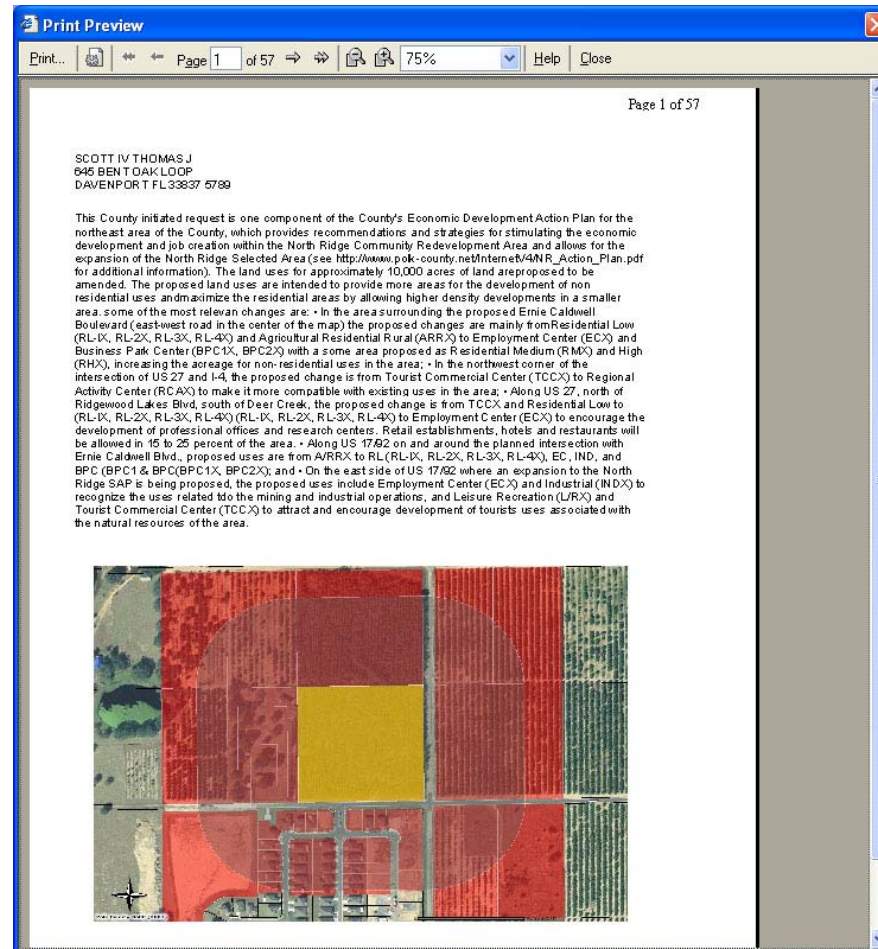
This County initiated request is one component of the County's Economic Development Action Plan for the northeast area of the County, which provides recommendations and strategies for stimulating the economic development and job creation within the North Ridge Community Redevelopment Area and allows for the expansion of the North Ridge Selected Area (see [http://www.polk-county.net/InternetV4/NR\\_Action\\_Plan.pdf](http://www.polk-county.net/InternetV4/NR_Action_Plan.pdf) for additional information). The land uses for approximately 10,000 acres of land are proposed to be amended. The proposed land uses are intended to provide more areas for the development of non residential uses and maximize the residential areas by allowing higher density developments in a smaller area. some of the most relevant changes are:

- In the area surrounding the proposed Ernie Caldwell Boulevard (east-west road in the center of the map) the proposed changes are mainly from Residential Low (RL-1X, RL-2X, RL-3X, RL-4X) and Agricultural Residential Rural (ARRX) to Employment Center (ECX) and Business Park Center (BPC1X, BPC2X) with a some area proposed as Residential Medium (RMX) and High (RHX), increasing the acreage for non-residential uses in the area;
- In the northwest corner of the intersection of US 27 and I-4, the proposed change is from Tourist Commercial Center (TCCX) to Regional Activity Center (RCAX) to make it more compatible with existing uses in the area;
- Along US 27, north of Ridgewood Lakes Blvd, south of Deer Creek, the proposed change is from TCCX and Residential Low to (RL-1X, RL-2X, RL-3X, RL-4X) (RL-1X, RL-2X, RL-3X, RL-4X) to Employment Center (ECX) to encourage the development of professional offices and research centers. Retail establishments, hotels and restaurants will be allowed in 15 to 25 percent of the area.
- Along US 17/92 on and around the planned intersection with Ernie Caldwell Blvd., proposed uses are from ARRX to RL (RL-1X, RL-2X, RL-3X, RL-4X), EC, IND, and BPC (BPC1 & BPC(BPC1X, BPC2X); and
- On the east side of US 17/92 where an expansion to the North Ridge SAP is being proposed, the proposed uses include Employment Center (ECX) and Industrial (INDX) to recognize the uses related to the mining and industrial operations, and Leisure Recreation (LURX) and Tourist Commercial Center (TCCX) to attract and encourage development of tourists uses associated with the natural resources of the area.

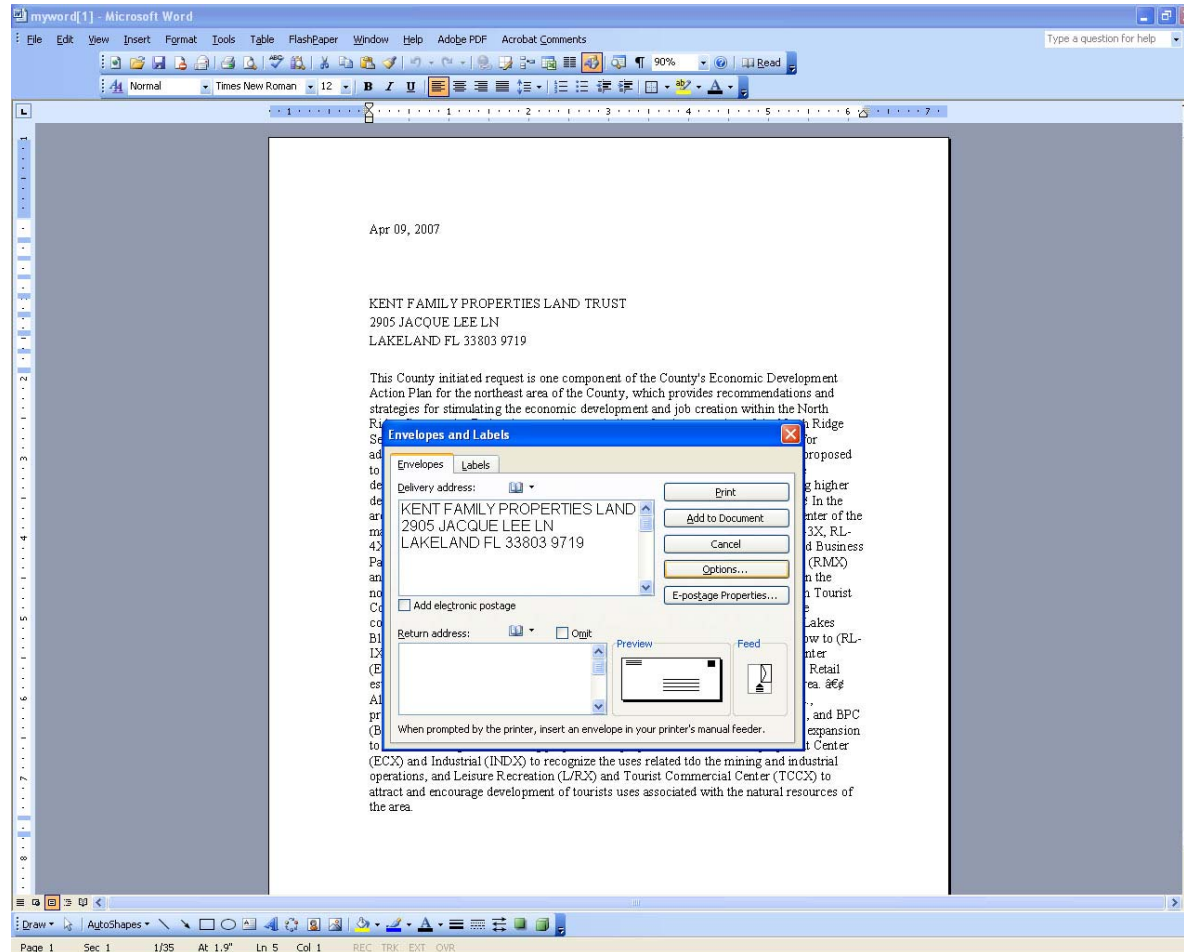
